Terms & Conditions

The recipient purchasing from Perfect Day Surf Camp accepts and agrees to comply with all of the terms and conditions set forth below.

- Parents must sign in the first day of camp & include email for cancellations or date changes. All other days check in and out with director only. No signature needed.
- Parents are welcome to visit on Fridays only. This will help your child progress. If you insist on being there, we suggest staying out of eyesight and do not let your child know you are there
- All campers get a wetsuit but the sizes and lengths are limited. A size too small or too big still works. Beach activities will replace ocean activities when weather conditions are not safe
- Do not use plastic or paper for lunches. Birds will eat through them.
- Label your child's gear.
- All surf campers must know how to swim. Beach campers can be beginner swimmers.
- Suspension is enforced after first warning for swearing, hitting, throwing sand or anything prohibited at the camp. Rules & regulations are explained the first day of camp.
- Parking is free drop off. \$7 all day for Santa Monica & Free or meters for Redondo
- A \$5.00 late pick up fee will be charged for every 10 minutes past end of camp
- All campers must have a signed release of liability. Campers under 18 must have a parent or legal guardian sign their release form

Refunds/Cancellations/Make up days

- Camp & Lessons will be conducted at the scheduled time unless weather conditions warrant otherwise.
- Camp is still in session if waves are too big and dangerous and cannot be made up. Beach activities requested by campers will be conducted.
- All refunds must be made in writing via email or by phone within 48 hours. There will be a \$15 administration fee for each class; \$25 for each camps.
- Please allow 6-8 weeks for refund processing.
- Registration is transferrable
- Any cancellation will be rescheduled for a make up in the same year if class is held
- Make up days must be in writing via email or scheduling with the office

SANTA MONICA DIRECTIONS TO DROP OFF LOCATION:

North of Santa Monica Pier (parking lot #9, tower 6) Take the 10 freeway west to Palisades Beach Rd. which turns into PCH (Pacific Coast Highway) pass the California Incline and the Jonathan Club, then turn into parking lot #9 which is the lot just South of The Annenberg Beach House lot. Meet us at the Roxy/Quiksilver Van to sign in and receive wetsuits.

REDONDO BEACH DIRECTIONS: MEET ON ESPLANADE AND KNOB HILL BY QUIKSILVER VAN
FROM NORTH: 405 S; Exit 42B Inglewood Ave; Right at Inglewood Ave; Right at W 190th St/Anita; Left at CA-1/S Pacific Coast Ave; Right at Knob Hill to the end where you see the van unloading or to the top of beach steps.

FROM SOUTH: 405 N; Exit 40 merge Artesia Blvd/CA-91 W; Left at CA-107/Hawthorne Blvd; Right at W 190th/Anita; Left at CA-1/S Pacific Coast Ave; Right at Knob Hill to the end where you see the van unloading or to the top of beach steps.

1.
