Terms & Conditions:

The recipient purchasing from Perfect Day Surf Camp accepts and agrees to comply with all of the terms and conditions set forth below.

- All campers must be paid in full and have a signed release of liability either online or at first day of camp.
- Parent/Guardian signature required first day of camp, but authorized pick up must sign out daily
- We want to continue to be one of the only camps that provide wetsuits, so please return them after camp or Perfect Day will be authorized to charge \$100 if not returned within two weeks from the day the wetsuit was missing.
- Parents are welcome to visit on Fridays only. This will help your child progress and avoid performance anxiety. It also confuses the staff as to who is watching your child. If you can't wait until Friday, we suggest staying out of eyesight and do not let your child know you are there.
- All campers get a wetsuit but the sizes and lengths are limited. A size too small or too big still works.
- Beach activities will replace ocean activities when weather conditions are not safe (no make up days for unsafe or "black ball" conditions) Black Ball is when lifeguard does not allow surfing due to conditions or over crowded areas (not common).
- Do not use plastic or paper for lunches. Birds will eat through them.
- Label your child's gear and bring own boogie board if you have one. We provide them to be shared.
- All surf campers must know how to swim. Beach campers can be beginner to non-swimmers.
- Suspension with no refund is enforced after first warning for swearing, hitting, throwing sand or anything prohibited at the camp. Rules & regulations are explained the first day of camp.
- Parking is free drop off. All day fees: \$7-\$9 meters
- A \$5.00 late pick up fee will be charged for every 10 minutes past end of camp (extended camp available online)
- We are a **Nut Free** environment – Please NO NUTS

Refunds/Cancellations/Make up days:

Most camps do not allow cancellations or changes once it begins. We want to offer flexibility but we need to be strict with our policy so we can continue to provide low student to instructor ratios. Also, our staff is eager and ready to work. It is not fair to them when we cancel last minute.

- No cancellations and refunds within 2 weeks of your start date.
- Refunds applicable if medical emergency or requested before 2 weeks from your start date and a \$25 non-refundable fee will be applied. **Two "sick" make up days** allowed in the same year in writing to info@perfectdaysurfcamp.com
- You can simply "edit" your days online in your account before 24 hours. **A \$15 admin fee will apply if not done before the 24 hours.**
- Any refund will be calculated and applied by the total days attended and "the price break for those days". Example, if you register for 5 days, attended one and granted a refund for the remaining days, you would be charged the full rate for one day you attended (not 5 day price break) and receive your refund.
- Please allow 6-8 weeks for refund processing.
- Camp & Lessons will be conducted at the scheduled time unless weather conditions warrant otherwise.
- Camp is still in session if waves are too big and dangerous and cannot be made up. Beach activities will be conducted.
- Registration is non-transferrable.
- Any cancellation by Perfect Day will be rescheduled for a make up in the same year if class is held
- All Days expire at end of Summer Schedule and can not be rolled over into the following season
- All 50/50 split payment balances are authorized to charge on June 1st and any outstanding balance will be authorized to charge on Sept 15th

Fee Policy:

- Select 5+ am or 5+ pm days to get your first price break.
- A \$25 registration fee per Summer will be applied to each camper and final payment is due by June 1st and Perfect Day Surf Camp has right to charge credit card on file for any outstanding balances.
- Price breaks are not available for splitting locations or splitting half and full days.
- Days do not need to be consecutive. The scheduling is flexible to meet your needs, but we need to be strict with our policy.
- Days can not be combined between siblings
- Days are non-transferable

CAMP CHECK LIST:

1. Non-paper or plastic lunch & bottle water (refills)
2. Sunscreen and spf lip balm
3. Labeled gear: sweatshirt, sandals, swimsuit, towel, hat, warm change of clothes
4. Boogie Board if you have one (we provide some to share)
5. Completed and signed release form if you did not do it online. You can easily do this in your account in the document center at the top left of the home page.
6. Payment if not complete
7. Money (optional) for camp hat, for restaurant, pier, farmers market (depending on location)
8. Bring the green rashguard daily that we provide on the first day
9. Please no nuts
10. \$7 Organic lunches available starting July 7th in Santa Monica only (if we meet the minimums) To order go into your account and "edit" your reservation and "edit" your options, click next until you get to the lunch page to add the **\$15 admin fee will apply for reservation changes and cancellations made without 24 hour notice, this includes changing ½ days to full days.**

LOCATIONS: Santa Monica, Redondo Beach, S. Redondo/Torrance and Manhattan Beach

Santa Monica (by Annenberg) Directions: drop off and check in at 475 Pacific Coast Highway at parking lot 9 just South of the Annenberg Beach House. (Not a mailing address). Meet in lot & our staff will walk them down to Quiksilver/Roxy tent on beach.

S. Redondo/Torrance (Torr Tower) Directions: at South end of the Esplanade and South end of large parking lot by Miramar Park. Exact drop off at 389 Paseo De La Playa and Via Riviera. Check in is at south end of parking lot by Camp Van. Camp will be at Quiksilver or Roxy tent on beach between lifeguard towers PA & TORR in front of Surfside Grill Restaurant.

City of Redondo's Knob Hill (No Living Social and these reservations are done through the city): Directions: drop off & check in at 100 Knob Hill Ave. on the sidewalk at Esplanade and Knob Hill (please do not block driveways or park in the red) We will walk campers down to Quiksilver or Roxy tent at Knob lifeguard tower.
